**ADOPTING BUDGET FISCAL YEAR:
From January 1, 2015 to December 31, 2015**

WHEREAS, the Annual Budget for the Township of Old Bridge, Fire District No. 4 for the fiscal year beginning January 1, 2015 and ending December 31, 2015 has been presented for adoption before the Board of Commissioners of Fire District No. 4 In The Township of Old Bridge, County of Middlesex at its open public meeting of January 31, 2015; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et.seq.) and

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$632,696, which includes amount to be raised by taxation of \$574,123, and Total Appropriations of \$632,696.39; and

WHEREAS, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount of money to be raised by taxation for the ensuing year.

NOW THEREFORE, be it RESOLVED by the Commissioners of Fire District No.4 In The Township of Old Bridge, County of Middlesex, at an open public meeting held on January 31, 2015 that the Annual Budget for Fire District No. 4, in the Township of Old Bridge, County of Middlesex for the fiscal year beginning January 1, 2015 and ending December 31, 2015 is hereby adopted, and shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$632,696 which includes amount to be raised by taxation of \$574,123 and Total Appropriations of \$632,696.39; and

BE IT FURTHER RESOLVED, that the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

BE IT FURTHER RESOLVED, that an annual election shall be held on the third Saturday of February to determine the amount of money to be raised by taxation for the ensuing year. The results of which shall be subsequently certified to the Division and the Municipal Assessor.
